Both sides of the Consent To Serve form must be completed and returned to the Association no later than 5:00 p.m., Friday, July 17, 2009.

Criterion for running for an Officer position is as follows:

“Individuals nominated to an Officer position shall have previously served on the Board of Directors of JTHS Association”.

Criteria for REALTORS® running for a Director position are as follows:

“Individuals nominated to a Director position shall have previously:

- a) served as Chairman of a Committee of a REALTOR® Association for one (1) year; or
- b) participated actively as a committee member of a REALTOR® Association for at least two (2) years; or
- c) successfully completed the Leadership Development Program of JTHS Association; or
- d) served as an Officer or Director of a REALTOR® Association.”

Criteria established for Affiliates running for a Director position are as follows:

- a) is a current active member of the JTHS Association; and
- b) has held a Chairman position within the past five (5) years; and
- c) is currently serving on at least one committee

“There may be one additional voting Affiliate Director who will be nominated by the Affiliate/Realtor Committee and elected by Affiliate Members for a term of one year. Voting rights will exclude Grievance and Professional Standards matters”.
